WHEREFORE, for the foregoing reasons Plaintiff Board of Trustees of the Jericho Baptist Church Ministries, Inc. respectfully requests that this Honorable Court grant the following relief:

- a. grant Plaintiff's Petition for Order of Contempt against Defendants Joel R. Peebles,
 Sr. and William A. Meadows and hold Defendants in contempt of its October 24, 2011 Order;
- b. order that Defendants Joel R. Peebles, Sr. and William Meadows, under oath, account for and turn over to Plaintiff all monies collected by Defendant Peebles at or through the Church for any purpose, within five (5) days from the date of the Court's order;

- c. order that Defendants Joel R. Peebles, Sr. and William Meadows, under oath, turn over to Plaintiff all bank statements and records for said monies collected by Defendants at or through the Church for any purpose, or paid from said monies, within five (5) days from the date of the Court's order;
- d. order that Defendant Joel R. Peebles, Sr. immediately cease and desist operating Joel Peebles Ministries and discontinue the website for www.joelpeeblesministries.com;
- e. order that Defendant Joel R. Peebles, Sr., under oath, account for and turn over to Plaintiff all monies collected by Defendant Peebles at or through Joel Peebles Ministries for any purpose, within five (5) days from the date of the Court's order;
- f. order that Defendant Joel R. Peebles, Sr., under oath, account for and turn over to Plaintiff all bank and financial statements and records regarding monies collected or paid by Joel Peebles Ministries for any purpose, within five (5) days from the date of the Court's order;
- g. order that Defendant Joel R. Peebles, Sr., under oath, disclose the name and address of all individuals to whom or entities to which he has paid monies as of or after the October 25, 2011 entry date of the Court's order, and the amounts paid to each individual or entity for any purpose, within five (5) days from the date of the Court's order;
- h. grant Plaintiff a constructive trust over all assets, accounts and any rights

 Defendant Peebles may have or be entitled regarding Joel Peebles Ministries, LLC;
- i. order that such further relief be granted with regard to Defendants as deemed appropriate following a hearing on Plaintiffs' Petition for Order of Contempt;
- j. award to Plaintiff the costs of these proceedings, including reasonable legal fees
 and costs; and
- k. award such other and further relief as this Honorable Court may determine to be just and proper.
